# The Bill and Melinda Gates Foundation, for the Grand Challenges Explorations, Round 12, due Nov 12

I want to be sure you are aware of an opportunity for funding from the Bill and Melinda Gates Foundation, for the Grand Challenges Explorations, Round 12. I would like to know if you or any of your colleagues choose to pursue an application, and would be happy to help with it. Please also forward this note to anyone else who might be interested.

Grand Challenges Explorations is an agile, accelerated grant initiative with short two-page applications and no preliminary data required. Anyone with a bold idea that shows great promise can apply. Applications are submitted online, and winning grants are chosen approximately 4 months from the submission deadline. Initial grants of \$100,000 are awarded two times a year. Successful projects have the opportunity to receive a follow-on grant of up to \$1 million.

A brief recap of the information from the website is below, but much more information is available for each on the website.

Topics for Grand Challenges Explorations Round 12 are:

1) Inciting Healthy Behaviors: nudge, disrupt, leapfrog, reach

We know there are many reasons people may not seek care or engage in preventative behaviors. We are seeking solutions that promote health-seeking behaviors and can make a difference in reducing morbidity and mortality and promoting healthy, productive lives. Solutions may target individuals, families, communities, health providers, or the health system. Solutions may include but are not limited to: education, campaigns, behavioral 'nudges', new support and incentive systems for access to care and treatment, and models and tools to understand health-seeking behaviors, constraints, and drivers. We seek solutions that are interactive, contextual, scale-able, and relevant to health systems strengthening.

Ideas must be relevant to low and middle income countries.

We're specifically interested in work targeting: reproductive health, maternal, neonatal, and child health, nutrition, HIV, TB, polio, and vaccine delivery.

## 2) Novel Enabling Tools and Models Supporting Development of Interventions for Enteric Dysfunction

In young children in the developing world, persistent and repeated bouts of enteric infection, malnutrition, and environmental factors interact in a complex and ill-defined way to negatively impact gut health and function. These events commonly lead to both a) repeated episodes of acute secretory diarrhea (ASD), and b) impaired gut function, commonly known as environmental enteric dysfunction (EED) or tropical enteropathy.

Given the pernicious broad impact of ASD and EED on nutrition, growth, cognition, immune response, and overall health, particularly in children under five years of age (our target population), we are interested in developing therapeutic interventions to improve child health in the developing world by identifying agents to restore normal gut function in the target population. Importantly, given the wide variety of bacteria, viruses, and other pathogens (e.g. cryptosporidium) that infect our target population, we are interested in developing host-directed therapies rather than agents that would kill the pathogen.

Thus, we are soliciting novel and innovative ideas for tools, approaches, and models to support preclinical development of new agents for ASD and EED. We particularly seek approaches which recapitulate the pathophysiology of impaired gut function as it occurs in our target population. We will consider a wide variety of approaches, provided a case can be made for how the approach will facilitate and support the development of new host-directed therapeutic interventions. We specifically request that applicants do not submit proposals focused on the identification and/or development of new therapies, as this is outside the scope of this GCE call.

## 3) Innovations in Feedback & Accountability Systems for Agricultural Development

The aim of this call is to solicit innovative solutions to build effective feedback and accountability in agricultural development programs. We are looking for tools that enable constituent voices to be consistently heard in all project phases. Your submission may address one or more of the following categories:

- New practices/systems to be used throughout all project phases to increase constituent feedback and/or enable communities to hold programs accountable;
- 2. Systems to evaluate existing feedback practices used by your organization. This evaluation should provide evidence of how your organization learns from constituent feedback and shares these practices with others:
- 3. Systems that enhance your existing feedback practices, e.g. new practices to make publicly available constituent feedback at regular intervals and in transparent and easily accessible ways; and
- 4. New practices/systems that effectively integrate cost-effective digital

technologies.

Proposals must (i) demonstrate that farmers' needs and perspectives were integral in the design of the solution; (ii) show how constituent voice will impact project implementation; and (iii) demonstrate how constituents will assess the effectiveness of the implementing organization.

4) The "One Health" Concept: Bringing Together Human and Animal Health for New Solutions

#### What We Are Looking For:

Novel and innovative ideas within the concept of One Health to address the issues in the following areas, ranging from early discovery concepts to delivery of solutions to measurement of impact:

- 1. Specific human and livestock diseases;
- 2. Health service delivery;
- 3. Measurement of impact.

To be considered all proposals must either draw ideas from animal health to address human health or vice versa.

#### 5) Develop the Next Generation of Condom

We are looking for a **Next Generation Condom** that significantly preserves or enhances pleasure, in order to improve uptake and regular use. Additional concepts that might increase uptake include attributes that increase ease-of-use for male and female condoms, for example better packaging or designs that are easier to properly apply. In addition, attributes that address and overcome cultural barriers are also desired.

Successful proposals will describe designs that are informed by data and/or knowledge of condom use and preferences, or of sexual practices, in the foundation's geographies of interest, specifically sub-Saharan Africa and southeast Asia. Proposals must (i) have a testable hypothesis, (ii) include an associated plan for how the idea would be tested or validated, and (iii) yield interpretable and unambiguous data in Phase I, in order to be considered for Phase II funding.

#### Tips for grant seekers

- Your proposal must represent an <u>innovative</u> approach that is responsive
  to the topic. The foundation has a number of other avenues of funding
  for the equally important research that is within currently accepted
  program paradigms.
- Applications are sent to reviewers without personal or organizational information. Do not include this information in the body of your proposal. Proposals that include personal or organizational information in the body of the proposal are at risk of being automatically removed from the review.
- Your proposal will be reviewed by a panel with broad expertise and a track record in identifying innovations - these reviewers may not be deep domain experts in your field. You must describe your idea in clear language without the use of jargon unique to your field.
- The work proposed in your application must include a clear set of key
  experiments or activities that test your idea in a way that could provide
  sufficient evidence to motivate Phase II funding. Proposals with vague
  descriptions or vague testing methodologies will not be funded.

Applications are due November 12.

"Civil" Society? On the Future Prospects of Meaningful Dialogue (2013-14 Speaker Series)

"The Perennial Racial Divide: Two Steps Forward, One Step Back"

Stephen Steinburg (Queens College, CUNY)

15 October 2013 - 5:30 pm Smathers Library (East), 1A

Sociologist Stephen Steinberg, Distinguished Professor of Urban Studies at Queens College, will discuss the current state of race in America. From the election of Barack Obama, to the Trayvon Martin case, to the recent Supreme Court rulings on civil rights legislation from 1964 and 1965, recent legislative and political discussions have revealed a highly polarized electorate on topics related to race. Steinberg will discuss this dynamic, asking us to reexamine our approach to achieving racial equality.

This event is part of the 2013-14 public speaker series organized by the UF Center for the Humanities and the Public Sphere to understand the dialogues (or lack thereof) about major political issues United States. Three fall 2013 presentations will explore why individuals, groups, and nations have difficulties sharing information and engaging in productive dialogue about life-and-death issues such as climate change, race, and our collective history. Three spring 2014 lectures will suggest how we might foster conditions that will bring us closer together, or at least help us to enter into broader dialogue about the human condition. This series is co-sponsored by the Rothman Endowment at the Center for the Humanities and the Public Sphere with support from the Office of Sustainability, UF Libraries, Honors Program, Department of History, Department of English, and Samuel Proctor Oral History Program.
