American Lung Association - Funding Opportunities - Due 12/15/14

Our office wanted to be sure you are aware of these opportunities for funding from the American Lung Association. If you or any of your colleagues choose to pursue an application, please let me know -- I would be happy to help with it. Please also forward this note to anyone else who might be interested.

The American Lung Association (ALA) offers annual funding opportunities as a part of its Awards and Grants Program. The goals of the Awards and Grants Program are as follows: 1) to foster laboratory, patient-centered and social-behavioral research designed to prevent and relieve the suffering associated with all lung diseases and corresponding risk factors; and 2) to fund researchers at important crossroads of their careers to gain long-term commitment to lung disease research.

1. <u>Allergic Respiratory Disease Award (Al)</u> - The Allergic Respiratory Diseases Research Award is for \$75,000 per year. The second year of support is based on demonstrating satisfactory progress, as well as, the availability of funding from the ALA and ARTrustTM. No IDC's are allowed. At the time of application, the applicant must hold a doctoral degree, have a primary faculty appointment in an allergy/immunology division/section of an academic institution, be undertaking a project related to allergic respiratory disease, and have completed a training fellowship. Applicants must be independent, self-directed researchers for whom their institution must provide space and other resources customary for independent investigators. The application must convey the commitment of the institution to the applicant and the proposed research activities. Applicants may be at any level of research experience but priority will be given to applicants at or below the rank of associate professor. A letter of intent is not required for the Allergic Respiratory Disease Award. For more information:

- Biomedical Research Grant (RG) : The objective of the Biomedical Research Grant is to provide seed monies to junior investigators researching the mechanisms of lung disease and general lung biology. The Biomedical Research Grant is for \$40,000 per year. A letter of intent is not required for the Biomedical Research Grant. - 3. Clinical Patient Care Research Grant (CG) The objective of the Clinical Patient Care Research Grant is to provide seed monies to junior investigators conducting trials for the improvement of patient care and treatment for lung disease. The Clinical Patient Care Research Grant is for \$40,000 per year. A letter of intent is not required for the Clinical Patient Care Research Grant. - 4. Dalsemer Research Grant (DA) The objective of the Dalsemer Research Grant is to provide seed monies to junior investigators researching the mechanisms and biology of interstitial lung disease. The Dalsemer Research Grant is for \$40,000 per year. A letter of intent is not required for the Dalsemer Research Grant. - 5. Senior Research Training Fellowship (RT) The objective of the Senior Research Training Fellowship Award is to support the training of recently graduated MDs and PhDs seeking further academic training as scientific investigators researching the mechanisms of lung disease and general lung biology. The Fellowship Award is for \$32,500 per year. Grants are subjected to annual review and may be granted for two years. A letter of intent is not required for the Senior Research Training

6. Social Behavioral Research Grant (SB) - The objective of the Social Behavioral Research Grant is to provide seed monies to junior investigators working on various disciplines of social science examining risk factors affecting lung health including: Psychosocial research, Behavioral research, Health services and health policy research, Epidemiology / Biostatics research, Public Health Education research. The Social Behavioral Research Grant is for \$40,000 per year. Grants are subjected to annual review and may be granted for two years. Pancreatic Cancer Action Network-AACR - funding opportunities due 10/8, 10/15 and 10/29/14

Our office wanted to be sure you are aware of these opportunities for funding from the **Pancreatic Cancer Action Network** and the **American Association for Cancer Research** (AACR). If you or any of your colleagues choose to pursue an application, please let me know -- I would be happy to help with it. Please also forward this note to anyone else who might be interested.

1. Pathway to Leadership Grant - The Pancreatic Cancer Action Network-AACR Pathway to Leadership Grant represents a joint effort to ensure the future leadership of pancreatic cancer research by supporting outstanding early career investigators beginning in their postdoctoral research positions and continuing through their successful transition to independence. Applicants must have started their postdoctoral or clinical research fellowship on or after July 2, 2010; i.e., the grant recipient must be in the first 5 years of their fellowship at the start of the grant term, and not already have a full-time tenure track assistant professor position (or equivalent). The Pathway to Leadership Grant provides up to five years of support, for a total of \$600,000, consisting of two phases. The initial Mentored Phase lasts up to two years, during which time the recipient will receive \$75,000 per year and is expected to work closely with a mentor(s) to develop a strong research project. During the subsequent three years, the recipient is expected to be in independent research position and will be funded at \$150,000 per year. It is anticipated that one Pathway to Leadership Grant will be funded. No indirect costs are allowed.

2. Career Development Awards - The Pancreatic Cancer Action Network-AACR Career Development Awards represent a joint effort to encourage and support junior faculty who have completed their most recent doctoral degree or medical residency within the past 11 years at the start of the grant term to conduct pancreatic cancer research and establish successful career paths in this field. The research proposed for funding may be basic, translational, clinical or epidemiological in nature and must have direct applicability and relevance to pancreatic cancer. The grants provide \$200,000 over two years (\$100,000 per year) for expenses related to the research project, which may include salary and benefits of the grant recipient, postdoctoral or clinical research fellows, graduate students and/or research assistants, research/laboratory supplies, equipment and publication charges for manuscripts that pertain directly to the funded project. No indirect costs are allowed. It is anticipated that multiple Career Development Awards will be funded.

3. Research Acceleration Network Grant - The goal of the Pancreatic Cancer Action Network-AACR Research Acceleration Network (RAN) Grant is to provide funding and strategic assistance to a research project with the potential to double survival for pancreatic cancer by the year 2020. This project must be implemented by a multiinstitutional team and include a clinical component with an endpoint relevant to improving the detection or treatment of pancreatic cancer. The RAN Grant will provide \$1,000,000 in funding for direct and indirect expenses related to the research project over a 1-3 year timeframe. In addition to the grant, the Pancreatic Cancer Action Network will provide strategic project management support to help optimize project implementation and progress during the grant term. It is anticipated that at least one Research Acceleration Network (RAN) Grant will be funded.

KRAS Fellowship - The Pancreatic Cancer Action Network (PanCAN) and the National Cancer Institute's (NCI) Frederick National Laboratory for Cancer Research (FNLCR) have joined together to award a Fellowship to a postdoctoral or clinical research fellow to conduct a research project that has a structural-based approach to the KRAS mutants that are relevant to pancreatic cancer (e.g., G12D and G12V). The selected postdoctoral or clinical research fellow will receive \$45,000 over one year for direct research expenses.
