Copyright for Online Teaching

Whether you are preparing an online course for UF students or getting ready to launch a course through Coursera, this workshop will assist faculty, instructional designers and others in navigating the copyright issues that arise when delivering course content online. The workshop will cover the law of fair use and the various alternatives available to delivering copyrighted content through the eLearning and Coursera platforms. How to Use the IR@UF: Uploading Content and Rights Management (with Christy Shorey, IR Manager)

The Institutional Repository (IR@UF) is a library sponsored digital archive for the scholarly works generated at the University of Florida by faculty, staff and students. This workshop will introduce the kinds of materials housed in IR@UF and demonstrate the process for uploading content into the IR via the self-submittal tool. Further, this workshop will explain the use and application of the new rights management statements incorporated into the IR@UF as well as UF's greater Digital Library. Usage of appropriate rights management statements better inform users of UF's digital collections of the copyright status of items that have been uploaded and shared as well as inform uses as to how that content may be reused.

Sharing Scholarship and Reaching Research: Open Access 101

Traditionally, scholarly research has been available only through expensive journal subscriptions. However, the open access movement promotes that high quality, peer-reviewed research and journals should be available to everyone online for free immediately after publication. This workshop is for anyone at UF who has never heard of or knows very little about the open access initiative and wishes to learn more.

HRSA Department of Health and Human Services Predoctoral and Postdoctoral Training in General, Pediatric, and Public Health Dentistry

HRSA has announced two solicitations for training in General, Pediatric, and Public Health Dentistry.

1. HRSA Department of Health and Human Services Postdoctoral Training in General, Pediatric, and Public Health Dentistry (HRSA-15-051)

This announcement solicits applications for the Postdoctoral Training in General, Pediatric, and Public Health Dentistry program. The purpose of this program is to improve access to, and the delivery of, oral health care services for all individuals, particularly low income, underserved, uninsured, underrepresented minority, health disparity, and rural populations. The goal of this FOA is to prepare postdoctoral trained dentists to practice in and lead new and innovative models of oral health care delivery to underserved and vulnerable groups, including programs that focus their activities at the population level. Applicants are encouraged to target their programs towards dentists who are likely to provide care for underserved groups and communities.

Grants will be required to focus on one or both of the following two Focus Areas:

- Focus Area 1: Developing and testing new training and delivery models in clinical training sites that prepare postdoctoral dentists to provide care for specified underserved groups or communities.
- Focus Area 2: Developing and testing new or enhanced training in dental public health and/or population health management. Applications must include didactic and experiential training to provide residents with the skills to assess population needs and use data to drive health system processes. Support for a Master in Public Health is allowed under this activity.

The maximum amount that may be requested per year for an application that includes accredited residency programs in one of the following disciplines: general dentistry, pediatric dentistry, or dental public health, is \$500,000. The project period is five (5) years.

2. HRSA Department of Health and Human Services Predoctoral Training in General, Pediatric and Public Health Dentistry and Dental Hygiene (HRSA-15-050)

The goal of this announcement is to enhance dental workforce education and

training to prepare predoctoral dental students, dental hygiene students, and dental hygienists to practice in new and emerging models of care that are designed to meet the needs of vulnerable, underserved, or rural communities. The emphasis will be on training in new models that stress the integration of oral health into larger care delivery systems and expanded roles of dental hygienists, under evolving State practice acts.

Propose predoctoral training programs in general, pediatric, or public health dentistry for dental students, dental hygienists, and dental hygiene students that address at least one of the following two focus areas:

- Focus Area 1: Enhancing training to support integration of oral health within the broader health care delivery system to improve access to oral health care for vulnerable, underserved, or rural communities.
- Focus Area 2: Training to support oral health providers practicing in advanced roles to improve access to vulnerable, underserved, or rural communities.

As part of the proposed Focus Area(s), applicants may develop and implement innovative programs to encourage and support students from underrepresented minorities, disadvantaged or rural backgrounds, and/or veterans to apply for, and be successful in, oral health professions training programs that are designed to ultimately place students in vulnerable, underserved, or rural communities.

2015 Cassen Postdoctoral Mentoring Award
\$100,000 over 2 years
Due January 15, 5 PM

Through the annual program, the foundation will award \$100,000 over two years to a junior scientist faculty member to recruit a postdoctoral fellow to support his/her research in the field of nuclear medicine and molecular imaging. The grant is intended to provide early-career scientists with mentoring experience as well as the opportunity to develop preliminary data for federal or other competitive research support.

The grant will provide support for the postdoctoral fellow to carry out the research under the supervision of the junior faculty member, with the assistance of a senior faculty member or principal investigator. Selection of a postdoctoral fellow from relevant disciplines outside nuclear medicine and molecular imaging is encouraged but not required. Overall administrative and research guidance for the postdoctoral fellow is to be provided by a senior mentor in the same institution.

To be eligible, applicants must hold a doctoral degree (M.D. or Ph.D. or equivalent) from an accredited institution; have a full-time position at an accredited university or medical school or equivalent in the United States; and be a citizen or permanent resident of the United States.

In addition, applicants must be no more than ten years beyond their doctoral degree or final year of postgraduate training, whichever is later, and have a senior mentor with significant research experience.

**American Brain Tumor Association - [Basic Research Fellowships](#)
\$100,000 over 2 years, no indirects
Due Noon, January 7**

The Basic Research Fellowships support new and early career scientists entering the field of brain tumor research. The experience provides an opportunity in which young, bright, motivated investigators learn from motivating mentors.

The fellowship provides \$45,000 in salary support and \$5,000 in researcher discretionary funds per annum. The discretionary funds are intended for research equipment, supplies, or travel to appropriate scientific meetings but must include a trip at the end of the award period to present research results. The fellowship award may be used only for salary support and researcher discretionary funds.

MDs must be within two years of residency completion (unless program mandates research studies earlier) or within four years of post-residency training as of July 1, 2015. PhDs must have their doctorate conferred by January 1, 2015 and will be no more than four years post-conferral of their PhD by July 1, 2015.

Research Training Award for Fellows:

Due date: Jan. 15, 2015
Funding: Up to 6 awards of \$55,000 each (1 year awards)

The ASH Research Training Award for Fellows (RTAF) is designed to encourage junior researchers in hematology, hematology/oncology, or other hematology-related training programs to pursue a career in academic hematology. The RTAF awards \$55,000 to fellows in training so they will have protected time for research and is to be used primarily for salary support for the applicant. Awards are targeted to two separate groups of researchers: a Junior Investigator RTAF for second and third-year fellows (apply in years one or two of fellowship) and a Senior Investigator RTAF for fourth or fifth-year fellows (apply in years three or four of fellowship).
