### Service-Learning in the Humanities: A Workshop for Interested Instructors and Community Partners

2 February 2015, Dauer Hall 215, 3:00-5:00 pm

Facilitated by Anita Anantharam (Center for Women's Studies and Gender Research) and Angela Garcia (Center for Leadership and Service)

What does Feminist Theory have to do with Slow Food? The answer to this

question is service-learning, a significant way for humanities scholars to connect theoretical ideas about the human condition to practical work in our communities. According to the National Service Learning Clearinghouse, servicelearning is "a teaching and learning strategy that integrates meaningful community service with instruction and reflection to enrich the learning experience, teach civic responsibility, and strengthen communities." In other words, service-learning combines pedagogy and community involvement to bridge the gap between the academy and the community and bring service into the classroom where teachers can utilize resources in the community, students can gain valuable cultural and professional experience, and community organizations can benefit from increased awareness and volunteerism.

This hands-on workshop will introduce UF teachers and community partners to the growing field of service-learning with particular attention service-learning components and strategies for humanities courses. The first part of the workshop will discuss existing service-learning courses in the humanities at UF, illustrate relevant student learning objectives, and provide resources for developing mutually-beneficial and sustainable relationships with community partners involved in service-learning courses. The second part of the workshop gives participants time and assistance to develop service-learning components to their existing or future courses. There will be ample time for Q&A and interactive planning by all participants.

This workshop is open to all UF faculty, staff, and graduate instructors. UF participants are encouraged to invite current or potential community collaborators to join them in the workshop.

Damon Runyon Postdoctoral Fellowship Award / Applications due on or before: March 16, 2015

The Foundation encourages all theoretical and experimental research relevant to the study of cancer and the search for cancer causes, mechanisms, therapies and prevention. Candidates must apply for the fellowship under the guidance of a Sponsor—a scientist (tenured, tenure-track or equivalent position) capable of providing mentorship to the Fellow. In addition to aiding in the planning, execution and supervision of the proposed research, the Sponsor's role is to foster the development of the Fellow's overall knowledge, technical and analytical skills, and capacity for scientific inquiry. The Sponsor is also expected to assist the Fellow in attaining his/her career goals. Awards are made to institutions for the support of the Fellow under direct supervision of the Sponsor. Candidates who have already accepted a postdoctoral research fellowship award are not eligible. The award is for up to \$320,000 over four years, no indirects.

## Damon Runyon-Sohn Pediatric Fellowship Award / Applications due on or before: March 16, 2015

The Damon Runyon Cancer Research Foundation has joined together with the Sohn Conference Foundation, dedicated to curing pediatric cancers, to establish the Damon Runyon-Sohn Pediatric Cancer Fellowship Award. This award provides funding to basic scientists and clinicians who conduct research with the potential to significantly impact the prevention, diagnosis or treatment of one or more pediatric cancers.

Candidates must apply for the fellowship under the guidance of a Sponsor—a scientist (tenured, tenure-track or equivalent position) capable of providing mentorship to the Fellow. In addition to aiding in the planning, execution and supervision of the proposed research, the Sponsor's role is to foster the development of the Fellow's overall knowledge, technical and analytical skills, and capacity for scientific inquiry. The Sponsor is also expected to assist the Fellow in attaining his/her career goals. Awards are made to institutions for the support of the Fellow under direct supervision of the Sponsor. Candidates who have already accepted a postdoctoral research fellowship award are not eligible. The award is for up to \$320,000 over four years, no indirects.

PhRMA Foundation - funding opportunities for Clinical Pharmacology, Health Outcomes and Translational Medicine and Therapeutics Programs - due 2/1/15

The PhRMA Foundation is now accepting applications for their programs in Clinical Pharmacology, Health Outcomes and Translational Medicine and Therapeutics. The deadline date for these applications is February 1, 2015. PhRMA foundation funds may not be used for indirect costs or fringe benefits.

#### CLINICAL PHARMACOLOGY

**Faculty Development Award in Clinical Pharmacology:** The purpose of this award is to encourage clinical pharmacology teaching, training, and research. Award recipients will receive two years of support at **\$120,000 per year**. Ideal candidates will have a minimum of four years total experience in a clinical pharmacology focused research program and residency training and a clear commitment to a career in clinical pharmacology.

#### HEALTH OUTCOMES RESEARCH

Health Outcomes research spans a broad spectrum of issues related to healthcare delivery, from studies evaluating effectiveness of a pharmaceutical intervention, to the impact of reimbursement policies on outcomes of care. It also ranges from the development and use of tools to perform patient-based assessments to analyses of ways in which results of outcomes research are disseminated to providers or consumers to encourage behavior change.

Outcomes research incorporates a variety of methods from different disciplines. The application of outcomes research principles in evaluating the design, delivery, and effectiveness of pharmaceuticals includes but isn't limited to the following general areas:

#### Pharmacoeconomics

Pharmacoeconomics evaluates behavior of individuals, organizations, and markets concerning use of pharmaceutical products, services, and programs. The discipline frequently focuses on costs (inputs) and consequences (outcomes) of pharmaceutical use.

#### Patient Reported Outcomes

Patient Reported Outcomes focuses on the value assigned to duration of life as modified by the impairment of physical, social, and psychological functional states, perceptions, and opportunities influenced by disease, injury, treatment, or policy. In this context, the field is also known as health-related quality of life.

- Comparative Effectiveness Research
- Patient Preferences
- Patient Centered Outcomes Research
- Compliance/Adherence
- Cost-Consequences Analysis
- Cost-Benefit Analysis
- Cost-Effectiveness Analysis
- Cost-Utility Analysis
- Health Outcomes Research
- Health-Related Quality of Life
- Health Services Research
- Health Technology Assessment
- Patient Satisfaction

Pre-Doctoral Fellowships in Health Outcomes

This award provides \$25,000 in stipend support per year for one or two years.

#### Post-Doctoral Fellowships in Health Outcomes

- Applicants must have a firm commitment from a sponsor/mentor at an accredited U.S. university.
- Applicants must hold a Ph.D., Pharm.D., or M.D. degree.
- Applicants are encouraged to apply at the earliest point possible in their postdoctoral research
- The fellowship provides a stipend of \$55,000, paid quarterly, for a period of two years.

#### Sabbatical Fellowships in Health Outcomes

- Eligible applicants must 1) hold a Ph.D., Pharm.D., M.D. or Sc.D. degree in a field of study logically or functionally related to the proposed post-doctoral activities, 2) hold a faculty appointment that presents eligibility for sabbatical leave from their institution, 3) have institutional approval of a sabbatical plan that includes partial salary matching the PhRMA Foundation stipend, and 4) have an endorsement from a mentor who agrees to sponsor the applicant's visiting scientist activity.
- Eligible candidates will have approval for sabbatical leave from their institution

and a commitment from the research mentor who will host them at the visiting institution.

- The applicant and mentor of the program must describe how the multidisciplinary goals of the research experiential program will be accomplished, and provide assurance that key collaborating mentors endorse and are willing to support the plan.
- Matching funds must be provided by the institution.
- A stipend of \$40,000, payable quarterly for a minimum of six months and a maximum of one year, will be provided.

#### **Research Starter Grants in Health Outcomes**

- Schools of medicine, pharmacy, public health, nursing, and dentistry are eligible for this award.
- This program is not intended for individuals in post-doctoral training. However, those enrolled in post-doctoral training programs scheduled to conclude by July 1, 2015, who will hold an academic appointment by that time, may apply.
- Those holding academic rank of instructor or assistant professor, and investigators at the doctoral level with equivalent positions, are eligible to apply—provided the proposed research is neither directly nor indirectly subsidized to any significant degree by an extramural support mechanism.

#### Funding

- The grant provides funding of \$100,000 for one year.
- The grant is paid on a quarterly basis to the university on behalf of the applicant, with the understanding that the university will administer the funds.
- The funds have limited restrictions a characteristic of the program.
- The funds may not be used for salary support of the grantee, but may be used to support technical assistance. The support of technical assistance may include the hourly wages of a technician; however the funds may not be used to provide fringe benefits or indirect costs for the technician.
- PhRMA Foundation funds may not be used for indirect costs or fringe benefits

#### TRANSLATIONAL MEDICINE AND THERAPEUTICS

"Translational medicine and therapeutics is a discipline focused on bridging experimental and computational technologies and discoveries in the research laboratory to their application in clinical practice. Examples of research components include activities in molecular and cellular biology, pathophysiology, systems biology, bioinformatics, modeling and simulation, and other quantitative sciences to connect basic biological concepts and entities to directly address unmet medical needs. The goals are to use clinical observation as the basis for hypothesis generation to further basic research and to efficiently advance the product of basic research to patients."

The Translational Medicine and Therapeutics program aims to promote development and use of experimental and computational methods in an integrative approach toward clinical needs in diagnosis, treatment, and prevention. This can involve enhanced understanding of human biological and disease processes, but requires a strong translational component. The program will support the concepts of translational medicine and therapeutics as defined by the Foundation and requires collaboration between basic and clinical research: Translational Medicine and Therapeutics awards will advance training and support career development of scientists engaged in research that significantly integrates innovative technologies with advanced biological, chemical, and pharmacological sciences and engineering methodologies in areas such as

- Genetics (Molecular, Pharmaco-, Population, Medical)
- Genomics (Functional, Structural, Toxico-, Pharmaco-, Comparative)
- Systems (Biology and Pharmacology)
- Pathways and Networks
- Integrative Biology
- Modeling and Simulation Target Identification and Validation
- Biomarker Discovery and Validation
- Vaccine Development
- Molecular Epidemiology
- Imaging
- Disease Modeling

Emphasis is placed on development of new experimental and computational approaches and technologies that facilitate translation of research into an elucidation and understanding of normal processes of human biology, as they function in disease, to directly support clinical needs.

#### Post-Doctoral Fellowships in Translational Medicine and Therapeutics

- Eligible candidates will have doctoral degrees, e.g., Ph.D., D.Sc., D.Eng., M.D., and seek to further develop and refine their skills and understanding of TMT through post doctoral training.
- Applicants must write and submit a research plan and provide the mentor's research record, as well as a description of how the mentoring experience will enhance the applicant's career development in TMT. A key component of TMT involves collaborative programs that span non-clinical and clinical domains, potentially involving multiple laboratories, advisers, and institutions.
- This award provides \$60,000 in stipend support per year for one or two years.

#### Research Starter Grants in Translational Medicine and Therapeutics

Those holding the academic rank of Assistant Professor (or Research Assistant Professor) within a tenure track (or Research track) appointment, or Instructor, if eligible to apply for independent research funding by their institution, are eligible to apply for these research starter grants, providing their proposed research is neither directly nor indirectly already being subsidized to any significant degree by an extramural support mechanism. Individuals receiving only intramural funding or start-up funding from their institution are eligible to apply for RSG awards

- Applicants will be judged on the scientific merits of the proposed research, and on the degree of need and fit within the scope and goals of the program.
- The program is not intended for those in postdoctoral training programs. However, individuals in postdoctoral training scheduled to conclude and who will hold an academic appointment by January 1, 2015, or the start of the grant period, may apply.
- The grant provides funding of \$100,000 for one year
- The funds may not be used for salary support of the grantee, but may be used to support technical assistance. The support of technical assistance may include the hourly wages of a technician; however the funds may not be used to provide fringe benefits or indirect costs for the technician


# Postdoctoral Associate in molecular aspects of age-related macular degeneration position
